 - Zoom webinar subscription



- Cheaper to have webinar subscription than to pay for in-person restaurant
- \$1600/annual subscription
- Possibly open attendance to other chapters
 - Subscription includes up to 500 people
- Run as a webinar (automatically mute participants, etc.) as opposed to a meeting
- Could use for PDC in 2021
 - May be able to incorporate hybrid option
- Other chapters/region may be able to contribute to the cost and share the subscription
- Proposed that a single month subscription be purchased as a trial for the August meeting
- Plan EC meeting beforehand to test it out

 - Vance Lee
 - July 23 vote results released
 - 7 motions on bylaws; all approved
 - 6/7 approved by 95% majority or more; dropping requirement for professional membership for leadership positions passed by 76%
