- Shameka Lewis announced quorum; the meeting was called to order at 4:03 pm

- o Catering (per Stephanie Johnson): Our catering department has terminated services to that building. However, you are allowed to order catering services to be delivered to the building. There are several great options in that Irving area that you could order those services for.

- PDC Status Jeff Hays
 - o Jeff was unable to attend the last few virtual PDC meetings with Greg May
 - o Shameka attended the last meeting and provided updates; there is not much action to take at this moment
 - o Will wait to announce an open call for speakers until later in the year (per Greg May)
 - Jeff suggested that we check out potential presenters on social media (TikTok, Facebook, etc.) to help judge their caliber before we invite "duds"
 - o Dusty suggested that we reach out to Greg May for a list of speakers who have been good (or bad) in the past
 - o Jeff sent out a document that proposed tracks for PDC 2024
 - The group agreed that having a track focused on mental health/psychosocial aspects of safety would be a great addition to our PDC
 - o Randall asked a question about when we put out a call for speakers, do we ask for specific topics (such as Lockout/Tagout, etc.)?
 - Other members answered that we typically ask for specific themes for our PDC speakers, but it is more open-ended for technical meeting speakers
 - However, we want to avoid speakers with a "sales pitch" as much as possible

 - o Abby suggested we continue to combine social events with the Fort Worth ASSP Chapter and to ensure that it's in the budget
 - o Not only do we get to network with our colleagues in the DFW area, but it helps cut down on both the cost and the logistical planning of the events
